## Terms and conditions of parking

1. A contract (hereinafter "Parking Contract") on the following terms and conditions (hereinafter "Terms and Conditions of the Parking Contract") is entered into between AS Tallinna Lennujaam (hereinafter "Parking Provider") and the user of the vehicle entering the corresponding car park of AS Tallinna Lennujaam (hereinafter "Vehicle User"). By presenting the Terms and Conditions of the Parking Contract, the Parking Provider is offering to enter into a Parking Contract. The Parking Provider considers the Vehicle User to have agreed to the Parking Contract on the presented Terms and Conditions of the Parking Contract upon the vehicle's entrance into the car park.
2. The Parking Provider has the right to presume the owner or responsible user of the vehicle to be the Vehicle User and thus a party entering into the Parking Contract.
3. After the parties have entered into the Parking Contract, the Parking Provider is obliged to allow the Vehicle User to use a parking space in a car park operated by the Parking Provider and to leave the car park after parking.
4. The Vehicle User is obliged to pay the Parking Provider a parking fee calculated based on time of entry, or to have a parking card or permission issued by the Parking Provider that grants the Vehicle User a right to park at the specific car park.
5. The parking fee is calculated based on the parking ticket that the Vehicle User is obliged to collect from the ticket machine at the car park entrance before entering the car park. Vehicle Users with parking cards issued by the Parking Provider must insert the parking card into the corresponding ticket machine upon every entrance to and exit from the car park (except for at car parks that use an automatic registration plate recognition system upon entry and exit) to prove their right to parking.
6. The parking fees, payment conditions and options are indicated on information boards at the car park entrances and in close vicinity of the car park payment machines at the Tallinn Airport passenger terminal or at the car parks of the Parking Provider. The temporary malfunction of one or several means for payment does not exempt the driver from the obligation to pay parking fees; another available payment option must be chosen.
7. The parking fee must be paid before exiting the car park in a vehicle. If the Parking Provider has issued a parking card or permit providing the Vehicle User

- with a right to park at the car park, payment conditions are agreed upon separately.
8. Only category A and category B vehicles that are registered in the traffic registry, that do not present a danger and do not negatively impact their surroundings and that have a clearly legible registration plate are allowed to be parked at the car park. Vehicles with trailers are forbidden from entering the car park. The maximum height of vehicles allowed to enter the -P1 and P0 levels of the Tallinn Airport parking house is 2.4 m.
  9. For the purpose of providing a taxi service, only taxis in a contractual relationship with AS Tallinna Lennujaam and ride-sharing cars that clients have pre-ordered by phone or via a mobile application can enter the car park. Public provision of taxi services without a permit issued by the Parking Provider or without the client having pre-ordered the service is forbidden at the car park.
  10. The Vehicle User takes responsibility for parking and driving in the car park. The Parking Provider is not responsible for any damages caused to the vehicle by the activity or inactivity of the Vehicle User or third parties during parking or driving in the car park.
  11. The driver must use the car park and their parking space prudently with the service's intended purpose, i.e. parking vehicles, in mind. Parking is only allowed in the designated area and in accordance with the directions, signs and guidelines issued by the Parking Provider. The vehicle has to be parked between the lines designating the parking space.
  12. Parking in the disabled parking space is only allowed for people who have been issued a disabled person's vehicle parking card by the local municipality. This parking card must be placed on the front window or in a visible area on the dashboard in order to use the parking space.
  13. If the Parking Contract is violated, the Parking Provider can request a contractual penalty of 50 euros from the Vehicle User. In case of continued violation, a new contractual penalty claim can be issued 24 hours after the previous claim. Paying the contractual penalty does not substitute paying the parking fee.
  14. If the Parking Contract has been violated by the same Vehicle User multiple times, the Parking Provider can temporarily or permanently ban their vehicle from entering and exiting the Parking Provider's car park via the automatic registration plate recognition system. If the repeated violations have been performed by a Vehicle User in possession of a parking card or permit issued by the Parking Provider, measures agreed upon in the contract entered into upon issuing the parking card or permit are enforced.
  15. If the Parking Contract is violated, the Parking Provider has the right to apply all legal remedies in accordance with the law, including stopping the vehicle from leaving the parking area until the parking fee and contractual penalty are paid and other damages to the Parking Provider arising from violating the Parking Contract are covered. After the Parking Provider receives the fees, they are obliged to allow the Vehicle User to exit the parking area in their vehicle.
  16. The Parking Provider has the right to move the vehicle from the parking area as set out by the law or if the Vehicle User has parked their vehicle in the parking area in a manner that blocks traffic or disturbs, hinders and/or endangers other users of the parking venue, if the vehicle damages the Parking Provider by being at the car park and/or if there is public interest. If a vehicle is moved, the Parking Provider has the right to store the vehicle at the moving site until all parking-related fees, including moving fees, have been paid.
  17. The Parking Provider has the right to assign claims deriving from the Parking Contract to a person performing a credit collection service, take the claim to county court and to make debt data public (payment default data) to the contractual partners as published on the web page of the Parking Provider.
  18. On matters not covered in the Parking Contract, parties shall apply the legislation in force in the Republic of Estonia.
